## Introduction

Council provides a range of services for which a charge or fee can be applied in order to recoup some or all of the cost of providing these services.

Council has limited revenue sources available to pay for growing demand for the provision of services. The main sources of revenue include rates and charges, government grants and user fees and charges. Council is experiencing growing pressure on rates and charges revenue sources and it is appropriate that it should recoup some or all of the cost of providing some services by direct user fees and charges where appropriate.

The Council Services Pricing Policy sets out the principles and framework for how prices for Council services are determined, reviewed and administered.

## Council Services Pricing Policy Objectives

The objectives of the Council Services Pricing Policy are to:

- Set principles for determining the price of services;
- Provide a framework for setting and reviewing prices for Council services; and
- Ensure that process set by Council comply with legislative requirements.

## Developing a basis for pricing

For every Council service where there is a charge, a unit cost will be calculated. This will determine the real price of providing the service and the level of subsidisation, if any, that will be applied in the price. If a unit-costing framework is not applicable, then an estimate of costs will need to be made.

## National Competition Policy - Competitive neutrality

Council is subject to the provisions of the National Competition Policy. Under the Competition Principles agreement, Council is obliged to apply competitive neutrality principles to all significant business activities undertaken by Council. This means that the prices Council may set for services provided by any significant business must reflect the full cost of providing that service, including notional costs incurred by competitors.

Competition neutrality however does not override the range of social, environmental, economic and regional responsibilities of Council in determining whether the application of competitive neutrality policy is in the public interest.

Council will determine any **significant business activities** it has from time to time under the Victorian Government's Competitive Neutrality Policy. Competitive neutral pricing principles will only be applied to services provided by significant business activities. Council will nominate any significant business activities in its annual national Competition Policy Report.

## Council or Statutory Fees

- Council fees are where council charges a fee to cover all or part of the full cost of providing the service.
- Statutory fees are where the maximum price or fee for a service is set by legislation and Council cannot charge more than the maximum fee.

## Goods and Services Tax (GST)

GST may apply to the price of some services. Council will identify which services will attract GST having regard to determinations made by the Federal Treasurer from time to time. Council's Manager Finance must be consulted in regard to GST matters as they relate to Council services.

## Price reviews

The level of process for all Council services will be reviewed annually. The review process will include:

- a) A review of the pricing principles that may apply;
- b) A review of the cost of the service;
- c) Regard to the price charged for similar services by other providers; and
- d) The level of subsidisation, if any, which might apply subject to Council's public policy objectives, included in the Council Plan and other policies and strategies.

Price reviews will be conducted so that:

- Any price changes are approved by Council in time for inclusion in any revenue projections for the next budget;
- Council staff have appropriate time to properly implement any new prices; and
- The users of the service have appropriate advance notice of any price change.

## Fees & Charges Schedule

Council will keep a Council Services Fees & Charges Schedule, which will be kept up to date and available to the public. The Fees & Charges Schedule for 2016/2017 is attached.

## Accountability process

Council will receive reports recommending the setting and review of fees and charges as per the Policy. All fees and charges will continue to be set by Council resolution or statute.
